

NOTICE OF PUBLIC HEARING
ON DISSOLUTION PROPOSAL

Notice is hereby given that the Board of Directors of the Orient-Macksburg Community School District will hold a public hearing on the 29th Day of July, 2024, at 5:30 p.m. local time, in the Orient-Macksburg Community School District Building, 201 South School Street, Orient, IA 50858, on the dissolution proposal submitted by the dissolution commission. This notice is being given pursuant to Iowa Code Section 275.54. The dissolution commission appointed by the Board prepared a proposal for dissolution of the School District, with attachment of all of the School District territory to one or more contiguous school districts and a division of the assets and liabilities of the School District. Said dissolution proposal has been filed with the Board and is incorporated by reference herein.

The dissolution proposal provides for the separate areas of the School District to be attached to contiguous school districts as represented in the map accompanying this Notice. The dissolution proposal provides for the assets and liabilities of the School District to be divided as follows:

The assets and liabilities of the Orient-Macksburg Community School District shall be divided among the contiguous districts, based on the division of the corresponding territory of the Orient-Macksburg Community School District and attachment to the contiguous districts. Real property shall be attached to the Nodaway Valley Community School District. All assets and liabilities will be divided per Iowa Code.

A copy of the dissolution proposal that is the subject of the public hearing may be reviewed at the office of the Board Secretary, located at Orient-Macksburg Community School District, 201 South School Street, Orient, IA 50858.

At the public hearing on the dissolution proposal, interested persons residing or owning land in the School District will be provided the opportunity to present evidence and arguments and otherwise express their views, both orally and in writing, on the dissolution proposal.

After the public hearing, the Board may make a final determination to adopt, or amend and adopt, the dissolution proposal.
